**Acknowledge and understand the following:**

1. As an incorporated club CLTC has a duty of care to both its members and all members of the public who interact with CLTC staff and CLTC members.
2. That as a part of CLTC's duty of care to its members and the public it is reasonable that CLTC enquire into the background of its coaches and person who apply for membership.
3. As a person applying for CLTC Membership I have been asked to sign the attached Declaration.
4. If I do not sign the Declaration my position as club member will be reviewed by CLTC/my application for membership will be refused.
5. That the Declaration I am being asked to sign relates to past offences, convictions or pending charges of a sexual nature.
6. It is my duty if I am in any doubt as to whether I should declare a conviction or any other matter set out in the Declaration to discuss the matter personally with the appropriate representative of Carina Leagues Triathlon Club, or seek independent legal advice, before signing the Declaration.
7. Matters of a "sexual nature" include indecent exposure and any other matter that could reasonably be regarded as involving an allegation of sexual behaviour in the context of a criminal offence.
8. In signing the Declaration I give CLTC permission to conduct a police check on me and again I understand that if I do not consent to the police check that my position as a club member will be reviewed and my application for membership with the CLTC will be refused.
9. The contents of this Declaration will be used by CLTC in a confidential manner to assess my suitability to continue in as member of the Carina Leagues Triathlon Club.
